NOTIFICATION

On the recommendations of the Warden (City Campus), the Vice Chancellor has been pleased to approve the Hostels Allotment Policy of UVAS for City Campus, 2020 as under:

1. Hostel allotment will be on purely merit basis and applications will be collected online at the time of admission.
2. Hostel facility will be first provided only to Morning students.
3. Merit of allotment for first year students will be made on the basis of their aggregates for admission against allocated seats across all degree programs in UVAS.
4. Currently Hostel Facility is not available for evening male students.
5. Hostel facility will be provided to 80% morning and 20% evening female students on merit basis against available seats.
6. Students with Lahore domicile are not eligible to apply for hostel accommodation.
7. Students enrolled at Ravi campus will not be allotted hostel at City campus.
8. Students who have been subjected to any major penalty by University will not be accommodated in hostel.
9. Students will have to submit an affidavit (on Rs.100 Stamp paper) to follow University hostel rules and regulations.
10. UVAS Hostel administration has the right to make necessary adjustments in hostel allotment following Government directions with reference to Covid-19.

UNDER GRADUATE 2ND YEAR AND ONWARD STUDENTS (FOR MALE STUDENTS ONLY)

1. Second year students will be moved from Iqbal Hall to Jinnah Hall.
2. Allotment in bi-seater rooms in Jinnah Hall will be on the basis of semester, class and merit.
3. Students will have to submit their applications in combination as mentioned by hostel administration.
4. Students can make combinations in their batch without discrimination of degree program.
5. New allotment of senior students will be made only subject to availability of new / vacant seats.

POST GRADUATE STUDENTS

1. M.Phil. students will be allotted on the basis of first come and first serve basis.
2. Hostel facility will only be provided to Morning class students.
3. Currently Hostel Facility is not available for evening male students.
4. Students from Lahore are not eligible to apply for hostel accommodation.
5. Students enrolled at Ravi campus will not be allotted hostel at City campus.
6. Accommodation will be provided to M.Phil Students for two years and PhD students for four years only.
7. Student who has been subjected to any major penalty by University will not be accommodated in hostel.
8. Students will have to submit an affidavit (on Rs.100 Stamp paper) to follow University rules and regulations.
9. UVAS Hostel administration has the right to make necessary adjustments in hostel allotment following Government directions with reference to Covid-19.
