Rules and Regulations

Aazaan competition:

- Only Boys Students from city campus can participate.
- The time duration for Aazan competition is 3 to 4 minutes.
- Tajweed mistakes and extra time will result in deduction of marks.
- The decision of Judges will be Final.

<u>HIFZ-UL-QURAN competition:</u>

- Hifz ul Quran competition is a prestigious event where participants showcase their memorization of the Quran. Here are five basic rules for such a competition:
- Eligibility: Participants must be Muslim, and their age and gender may be restricted based on the competition's guidelines. Generally, participants must have memorized the entire Quran.
- **Recitation**: Participants must recite the Quran from memory, with proper Tajweed (rules of Quranic recitation) and fluency. Judges may evaluate based on accuracy, pronunciation, and rhythm.
- **Time Limit**: Each participant is given a specific time limit to recite a portion of the Quran. This ensures fairness and allows for the efficient management of the competition.
- Judging Criteria: Judges assess participants based on memorization accuracy, fluency, Tajweed, and overall presentation. They may also consider the participant's age and experience level.
- **Disqualification**: Participants may be disqualified for any violation of the rules, including using a Quran text or notes during the recitation, exceeding the time limit, or failing to meet the competition's standards of recitation.
