CHAPTER 25

SPORTS RULES

The following rules have been framed for the organization of Sports and the management of sports affairs in this University. These rules shall supersede all previous rules and regulations on the subject. However, the Vice Chancellor is authorized to make such rules as may be necessary, from time to time.

A) Composition and Power of the Sports Board

- 1. There shall be constituted a University of Veterinary and Animal Sciences, Lahore Sports Board
- **2.** The Sports Board shall consist of:
 - a) a Chairman and two other members to be nominated by the Vice-Chancellor amongst the teachers of the University.
 - **b**) Senior Tutor
 - c) Director, Students Affair.
 - d) Treasurer or his representative (not below the rank of Dy.
 Treasurer)
 - e) The Director of Sports-ex-officio member and Secretary

- **3.** The Sports Board shall lay down general policies for the conduct of sports and shall exercise general supervision over the sports affairs.
- **4.** Four members shall form a quorum for meetings of the Board.
- **5.** In the absence of the Chairman, the senior most member of the Board, shall preside over the meeting of the Board.
- **6.** All decisions shall be taken by a majority of votes of the members present. If votes, including that of the Chairman are equally divided, the Chairman shall have a casting vote.
- **7.** The Board shall meet as often as may be considered necessary according to the circumstances.
- **8.** Without prejudice to the provisions of Rule-7, an annual meeting of the Board shall be held in the Ist week of May / June every year to consider the Sports Budget Estimates to be presented to the appropriate authorities of the University for approval.
- **9.** A notice of three days shall be given for an ordinary meeting of the Sports Board but an emergent meeting may be held at such shorter notice as may be determined by the Chairman.

B) Function of the Director of Sports

1. Subject to the provisions of these rules and the general instructions issued by the Sports Board, the Director of Sports shall perform the following functions:

- a) Shall organize sports tournaments within the University and to prepare the annual sports programme for the approval of the Sports Board.
- **b)** Shall organize sports clubs and teams to take part in the intervarsity and other tournaments and matches.
- **c**) Shall promote generally the cause of sports and inculcate qualities of sportsmanship amongst students.
- **d)** Shall nominate President and Vice-Presidents of various games of the University with the concurrence of the Chairman of Sports Board.
- e) Shall prepare the annual budget for the consideration of the Sport Board.
- **f**) Shall maintain accounts and stores in accordance with the rules and instructions issued by the University.
- **g**) Shall supervise and maintain the University play grounds, courts and other sports facilities.
- **h)** Shall maintain a record of the members of University teams and their performances and achievements.
- 2. The Director of Sports may permit a play ground, court or any other sports facility to be used by Sports Clubs, Associations, teams or individuals not connected with the University for the purposes of non-University tournaments, matches and other sports events on payment (determined by Sports Board from

time to time) with such terms and conditions as the Director of Sports may impose after the approval of the Sports Board.

C) Sports Funds and Financial Powers

- **1.** The Sports funds shall consist of the contributions made by the University for sports and games.
- **2.** All amount paid into the fund shall be deposited by the Treasurer with the bankers of the University in a separate account named "Athletics / Sports fund, U.V.A.S., Lahore
- **3.** All payments from Sports Fund shall be made by the Treasurer.
- **4.** The Chairman Sports Board shall have full financial powers to sanction any expenditure for which provision has been made in the Budget estimate of the Board.
- **5.** No expenditure shall be incurred unless funds are available for the purpose.
- **6.** The Director of Sports shall exercise the same financial powers as other Heads of Departments of the University.

D) Sports Activities

- **1.** Following Sports activities may be financed out of the Sports fund:
 - i) Athletics
 - ii) Badminton
 - iii) Basket ball
 - iv) Cricket

- v) Foot Ball
- vi) Hiking
- vii) Hockey
- viii) Indoor Games
- ix) Rifle Shooting
- x) Swimming
- xi) Table Tennis
- xii) Tennis
- xiii) Volley Ball
- xiv) Body Building
- xv) Judo Karate & Boxing
- xvi) Tent Pegging
- xvii) Weight lifting
- xviii) Wrestling
- xix) Hand Ball
- xx) Any other game approved by the Sports Board
- **2.** Equipment needed for various games and sports shall be purchased in accordance with the University Purchase Rules.
- **3.** The following sports events shall be conducted in the University annually in accordance with the rules and regulations indicated in each case.

4. For the purposes of the University Sports tournaments, the Sports Board may modify any of the above rules.

E) Scale of Expenses

- 1. A University sportsman participating in an organized tournament outside the University Campus at Lahore, shall be paid the actual charges spent on transportation as certified by the President of the Club.
- **2.** A sportsman participating in an organized tournament outside Lahore as a representative of the University shall be paid:
 - a) First Class Railway fare (or / and A.C. Coach / bus fare where the journey or part of the journey is performed by A.C. Coach / bus) to and from the place where the tournament is held and other incidental traveling expenses such as cooli charges, tanga and taxi fare; and
 - **b)** Rs. 100/- per day as an allowance during the period of his journey to and from the place where the tournament is held and during his stay there:

Unless he is paid by the authority sponsoring such tournament.

- **3.** Where the traveling and food expenses received by a sportsman from the authorities sponsoring the tournament fall short of the charges admissible under the preceding rule he shall be paid the difference from the Sport Fund.
- **4.** Presidents / Vice-Presidents accompanying a team shall be entitled to draw his / their traveling allowances in accordance with the University Traveling Allowances Rules.
- 5. The Director of Sports may permit an attendant to accompany a team. Such an attendant shall be entitled to draw traveling allowances in accordance with the University traveling Allowance Rules.
- **6.** All Notification regarding attendance of the players in the various games shall be issued by the Director of Sports.
- 7. Accommodator for sportsmen participating in tournaments outside Lahore should be arranged for wherever possible, in University, College and School Hostels or Boarding Houses. If it is at all necessary to stay in a hostel the prior permission of the Chairman, Sports Board shall be obtained and he may fix the lodging charge.
- **8.** In University sports tournaments, contestants in individual events securing the first three places shall be awarded prizes (plus certificate) at the following rates:

(i)	First	Rs.100/-
(ii)	Second	Rs.70/-

(iii) Third Rs.50/-

- 9. In the case of sportsmen representing the University in the intervarsity Zonal / National Championship, refreshment charges shall be allowed at a rate not exceeding Rs.25.00 per head per match. This will be in addition to the allowance of Rs.100/- per Diem admissible for food expenses. However Rs.50/- per head per match will be give to Sportsmen in case of playing within the city of Lahore, for refreshment.
- **10.** A training and coaching camp may, with the prior approval of the Chairman of the Sports Board, be organized for a game before the intervarsity championships but the duration of the camp shall not exceed six weeks. Diet money at the rate of Rs.20/- per head per day may be allowed to the trainees at the camp.
- 11. If a sportsman of the University is selected as a member of a National Team or for participation in a National / Pakistan Universities team to play outside Pakistan, he may be given an outfit allowance not exceeding rupees one thousand.
- **12.** Articles and medicaments required for First Aid treatment may be purchased collectively and adequate issued to a team as and when required.
- 13. A player injured in a practice or regular match, organized at the University grounds or in a recognized match outside the University may on the recommendation of the University Medical offices, or other Medical Authority, if the Injury occurs outside Lahore, be treated in a recognized hospital or referred to a recognized Medical Specialist for treatment.

Medical charges incurred in this connection will be reimbursed from the Sports fund on production of actual payment receipts verified by the University Medical Offices as representing legitimate Medical charges.

- **14.** The Chairman, Sports Board, may sanction special expenditure entertainment in connection with special sports events.
- **15.** Each sportsman selected as a member of a University team is entitled to get track suit and a free kit according to game point of view. List of games is as under:

16. Lunch will be provided to the players and Officials during whole day Cricket Matches.

F) University Team

- 1. Members of a University team shall be selected by a Committee consisting of the Director of Sports, the President / Vice-President and another member nominated by the Chairman Sports Board.
- **2.** The captain of a team shall, as far as possible, be appointed on the basis of seniority.

G) Office Bearers of the Sports Club

1. There shall be office bearers for each game; President and Vice-President amongst the teaching staff and Captain and

Vice-Captain amongst the students, who has once held an office is not eligible for re-appointment to the same office.

- 2. The captain / vice captain of a team shall, as far as possible, be appointed on the basis of seniority which shall be determined as follows:
 - i) The number of years a sportsman has played for the University in the Intervarsity championship.
 - ii) If the seniority of two or more sportsmen as determined under clause (a) above is equal, a sportsman who is or has been a member of a National team shall be preferred to a person who is or has been a member of such team. A playing member shall be preferred to a reserve member.
 - **iii**) If the seniority of two or more sportsmen as determined under clauses (i) & (ii) above is equal, a sportsman studying in a higher class shall be given preference over a sportsman studying in a lower class.
 - iv) If the seniority of two or more sportsmen as determined under clauses (i), (ii) and (iii) above is equal, the Director of Sports shall, in consultation with the President, appoint from amongst them as captain, a sportsman who, in his opinion, is best qualified for the office on the basis of qualities of leadership, organizing ability, general behaviour and proficiency in the game.

H) <u>University Colour</u>

- 1. The University Colour means the insignia of the University with the name of the particular game worn on a coat pocket.
- 2. The following shall be entitled to wear the University colour:
 - (a) A person winning the first place in an individual event in a National or Intervarsity Championship.
 - (b) A person selected as a member of a National team or a Pakistan Universities team.
 - (c) A person played at least 3 years Interuniversity championship and scored position.
- **3.** A person who had been awarded colour in a game shall not be eligible for the second colour in the same game.
- **4.** No person shall be eligible for the award of colour if in the opinion of the Sports Board, his conduct has not been consistently good.
- **5.** A person awarded the University colour shall be granted a certificate of authority to wear it.
- **6.** The colour may be withdrawn by the Sports Board if the holder is found guilty of misconduct or indiscipline.
- **7.** The Vice-Chancellor may set aside or alter any decision of the Sports Board.
