

RULES FOR THE CONDUCT OF BUSINESS OF THE SELECTION BOARD OF THE UNIVERSITY OF VETERINARY AND ANIMAL SCIENCES, LAHORE

1. **Short Title:** These Rules may be called the Rules for the conduct of Business of the Selection Board of the University of Veterinary and Animal Sciences, Lahore.
2. **Definition:** In these rules, unless the context otherwise requires, the following expressions shall have the meaning hereby assigned to them as under, that is to say:
 - (a) 'Selection Board' means the Selection Board of the University of Veterinary and Animal Sciences, Lahore constituted under "The First Statutes" appended with the University of Veterinary and Animal Sciences, Lahore Ordinance, 2002: and
 - (b) 'Chairman' means the presiding officer.
3. The Vice Chancellor shall preside at all meetings of the Selection Board. In the absence of the Vice Chancellor a member of the Selection Board chosen by the majority of the members present from among themselves, shall preside.
4. The Registrar shall act as non-member Secretary of the Selection Board of the University.
5. The meetings of the Selection Board shall be convened by the Secretary under the direction of the Vice Chancellor as occasion may require.
6. The quorum of the Selection Board in case of selection of a Professor or Associate Professor and other teachers shall be four and three respectively. In case of officers, other than teachers, the Selection Board shall consist only of members mentioned at (i), (ii) and (v) of sub-paragraph (1) and the required quorum shall be three.
7. All members present in a meeting shall individually grade the candidates appearing for interview against an advertised post, reaching a consensus decision on the selectee against each post at the conclusion of such interviews. In the event of difference of opinion among members present, the decision shall be arrived at by majority votes. In case of equal votes on a subject, the Chairman shall exercise his casting vote.
8. The minutes of the meeting shall be recorded and signed by the Secretary and got confirmed by the Chairman within a week of the last date of the meeting.
9. The confirmed minutes of the meeting shall be circulated immediately among the members. Any omission or error pointed out by any member within a week of the receipt of the minutes shall be put up to the Selection Board at its next meeting.

CONSTITUTION OF THE UVAS LAHORE SELECTION BOARD

- (1) The Selection Board shall consists of:
 - (i) the Vice Chancellor (Chairman);
 - (ii) the Chairman or a member of the Punjab Public Service Commission to be nominated by the Chairman:
 - (iii) the Dean of the Faculty concerned or Director of the Division or Principal of the College, as the case may be.
 - (iv) the Chairman of the Teaching Department concerned; and
 - (v) One member of the Syndicate and two other member of eminence to be appointed by the Syndicate; provided that none of the three are employees of the University.
- (2) The members mentioned in clause (v) of sub-paragraph (1) shall hold office for three years.
- (3) The quorum of Selection Board in case of selection of a Professor or Associate Professor and other teachers shall be four and three respectively. In case of Officers other than teachers the Selection Board shall consist only of members mentioned at (i), (ii) and (v) of sub paragraph (1) and the quorum shall be three.
