- viii) The Scholarship will be terminable in the following cases:
 - a) If the student fails to maintain class attendance of 75%.
 - b) If the student is involved in malicious/undesirable activities.
 - c) If the student fails to obey or act in accordance with HEC's order directing him/her, he/she will be liable to action under the acts/rules in force in the country.
 - d) If the student is punished because of his involvement in violation of the institute rules, damage to institute property, misbehaviour with staff or colleagues or any other disciplinary action.
 - e) If a student remains absent from classes for one week (6 or 5 working days, as the case may be) continuously without a valid excuse acceptable to the authorities as per rules of the Institute.
 - f) If the information provided by the student is found incorrect at any time during his study period.
 - g) If the student fails to maintain academic standards of the university
